## *Final Reminder*

To all Licentiates of INPP worldwide  
and practitioners who qualified in the UK in 2019

Dear Colleagues

We are all living through extraordinary times, and sometimes when the adaptations required and restrictions imposed seem difficult, I must remind myself that we are the lucky ones.

Although the regulations are different for every country, the virus is not, and I think it is probable that restrictions on travel and large public meetings will continue for many months to come in many countries.

In this context, INPP in the UK will be offering the annual supervision days *for this year* online and it has occurred to me that this presents an opportunity for many Licentiates from other countries to join UK based supervision days for the first time.

I would like to stress that this is not obligatory for Licentiates who have attended supervision days in the first 18 months after successfully completing the final examinations or who are up-to-date with supervision requirements. *It is obligatory for INPP practitioners who completed INPP examinations in the UK in 2019. This group will be required to prepare a 10 – 15 minutes presentation on an aspect of INPP practice to deliver during the first day.*

These supervision days do not replace the need to attend other supervision days with your national Principal but is an open offer to anyone who would like to participate.

### **Dates for online supervision days in the UK for 2020 are:**

**Saturday 14<sup>th</sup> November**

**Sunday 15<sup>th</sup> November**

The first day is generally more focused on issues encountered by recently trained practitioners and may not be of interest to practitioners who have several years' experience.

The second day will be dedicated to questions or topics sent in by practitioners and it is my hope that other Principals will also join the meeting and participate in answering/discussing some of the issues. Licentiates are also invited to make short presentations online demonstrating aspects of practise or research that are of interest to all.

I have now provided several days of teaching using an online format and been at the student end as an attendee of a JIAST online update. My experience is that meetings and training through this medium are tiring and sessions of 3 – 4 hours, with short breaks, are optimal. This being the case, and to try to accommodate Licentiates in different time zones, I suggest that Day 2 is offered as two separate sessions of 3 hours in the morning and 2+ hours in the afternoon.

Session 1        09.00 – Noon (UK time)  
Session 2        14.00 – 16.00+ (UK time)

Licentiates may choose to attend one session only, or the full day.

The cost of attendance will be £50 *per session* plus VAT.

**All questions, topics or applications to provide a short presentation to be sent in advance, to be received by the 7th October 2020 using the registration form below.**  
**Please send these as soon as possible to enable us to prepare the most useful supervision content for you over each session.**

If there is a demand for this format, it is something we will consider offering in addition to face-to-face supervisions again in the future.
